(3) Your "Job Duties" are those duties described in Section 1, as well as those duties as may from time-to-time reasonably be prescribed by the Company during the period of your employment or contract with the Company.

(4) "Customers/Clients" means any firm, partnership, corporation and/or any other entity and/or person that contracts from the Company any security services mentioned, but not limited to those in Section 2.a.(1).

(5) "Customer Prospects" means any firm, partnership, corporation and/or any other entity and/or person reasonably expected by the Company to contract work from the Company any of the services, but not limited to those mentioned in Section 2.a.(1).
